- F. PLANNING COMMISSION UPDATE. No comments from Council.
- G. DISCUSSION ON HB3115. Tate briefed the Council on HB3115. The bill was passed by the Oregon Legislature in 2021 and goes into effect on July 1, 2023. It provides that local law regulating sitting, lying, sleeping, or keeping warm and dry outdoors on public property that is open to the public must be objectively reasonable as to time, place, and manner with regard to persons experiencing homelessness. The City Attorney indicates that he feels Durham is currently in compliance with HB3115, but that he would help the council draft a time-place-manner ordinance now or in the future if they feel the need. The Council agreed that the ordinances are sufficient for now. Commissioner Drake asked about the requirement to have shelter space available. Tate commented that we contract with Tualatin Police Department and they can help find a place for a houseless person to go. Local municipalities are working together to provide that space.

- City Administrator Tate provided information to help the Council develop a recruitment timeline and process to fill the City Administrator position that will become vacant upon Tate's retirement on December 31, 2023.
