NOTICE IS HERE GIVEN THAT an application for tree removals will be heard by the Durham Planning Commission at Durham City Hall and via Zoom, at or shortly after, 7:00 P.M. on December 2<sup>nd</sup>, 2025, to consider the following request:

Requests: Tree removal application #826-25, which requests the removal of 8 Douglas

Fir trees, as follows: Tree #23 - 37" DBH; Tree #24 - 38" DBH; Tree #26 - 27" DBH; Tree #27 - 27" DBH; Tree #28 - 50" DBH; Tree #29 - 13" DBH;

Tree #30 – 20" DBH; Tree #24 – 30" DBH.

Applicable Criteria: The approval criteria for the applications are provided in Durham

Development Code (DDC) under Chapter 3 Site and Design Standards, Section 3.1 Standard Site Design in Residential Zones, Section 3.7 On-Site Access and Off-Street Parking, Section 3.9 Street Design, and Section 3.10 Protection of Transportation Facilities; Chapter 5 Tree Protection; Chapter 8 Subdivision requirements; Chapter 9 Procedures, Section 9.6 Type 2 Process

and Criteria; and Tree Protection Ordinance 228-05 as amended by Ordinance 246-08; and the Durham Comprehensive Land Use Plan as

revised 6.23.95.

The Planning Commission meeting on this matter will be conducted pursuant to the rules of procedure adopted by the City Council. Written or oral comments in favor of, or in opposition to, the request must be submitted to the City Administrator no later than November 28<sup>th</sup>, 2025, by 4:00 P.M.

Failure to raise an issue, or failure to provide sufficient specificity to afford the decision-makers an opportunity to respond to the issue, precludes appeal on said issue to the State Land Use Board of Appeals, or to seek damages in circuit court due to a condition of approval.

The application and pertinent documents are available for inspection at no cost (copies provided at reasonable cost) at Durham City Hall, 17160 S.W.
